IMPORTANT NOTE

Due to the release of a new version (6.0*) which will become available in January 2020, we inform you that:

- If you order your subscription before **15/11/2019** you will receive credentials for the current version (5.0) which you will be able to use until the end of 2019 and, in November, credentials for the new version (6.0*) which you will be able to use as from January 2020.
- If you order your subscription after **14/11/2019**: you will receive credentials for the new version only (6.0*) which you will be able to use as from January 2020. You will not have the possibility to use CombiStats in November & December 2019.

*Version 6.0 implements the change brought in Chapter 5.3 of the European Pharmacopoeia – 10th Edition – about the semi-weighted combination of assay results (adopted as part of the 162nd Session of the European Pharmacopoeia Commission). This new version will be made available by 01-Jan-2020 when the new chapter comes into force.

The 2020 licence for CombiStats runs until **31/10/20** for a single user licence - one licence per PC. The price per licence is €300 – this is irrespective of when you order during the licence period. No discount for multiple purchases is available.
