The following list is provided for information to facilitate the organisation of OCABR by MAH/manufacturers when OCABR is requested. Manufacturers are encouraged to take advantage of all of the resources in the VBRN for OCABR testing.

The list is based on information provided by the CA/OMCLs in the VBRN. All Member States have been given the opportunity to respond. The list will be updated as needed when new information is received from the VBRN members. It is the responsibility of the Member State to keep their information up to date by notifying EDQM.

The absence of an OMCL from this list does not exclude the possibility that they may in future be able to provide OCABR certificates for a given product group. Direct contact between the OMCLs and the manufacturers for further information is strongly encouraged.
