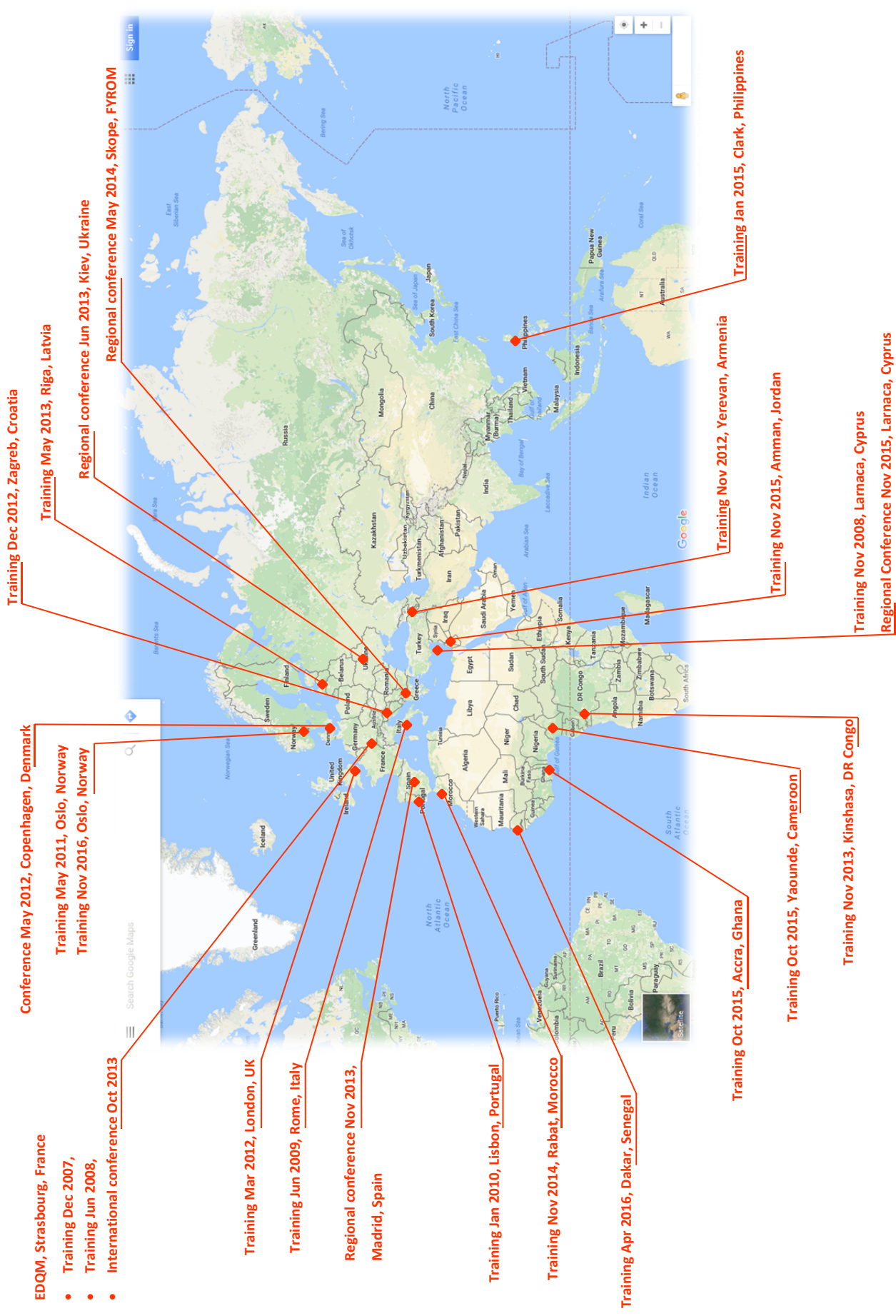


## Overview – Activities related to MEDICRIME

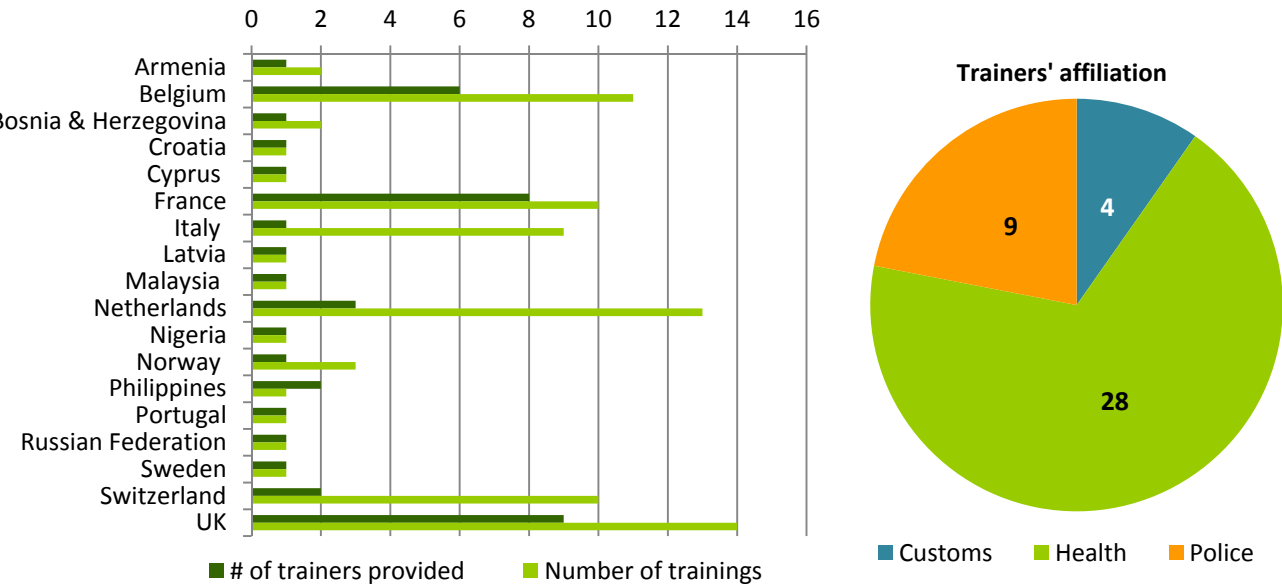

<b>Number of trainers</b>	42	From 18 countries

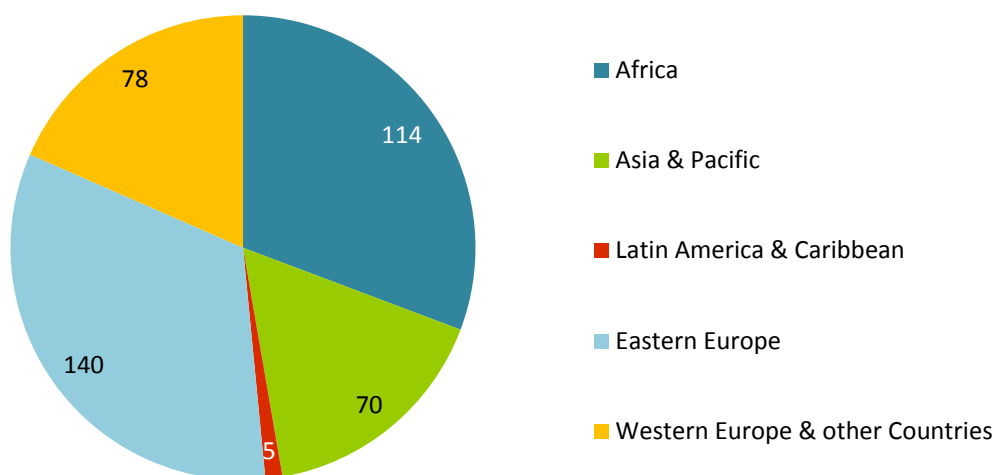
**Information about Trainers**

Eighteen countries have provided trainers to form participants on topics related to MEDICRIME, the SPOC network and inspections. Below are shown the number of trainers coming from the various countries, as well as the number of trainings which the countries have supported in this way. As shown in the graph on the right, the trainers come from all three main professional backgrounds – health, police and customs.



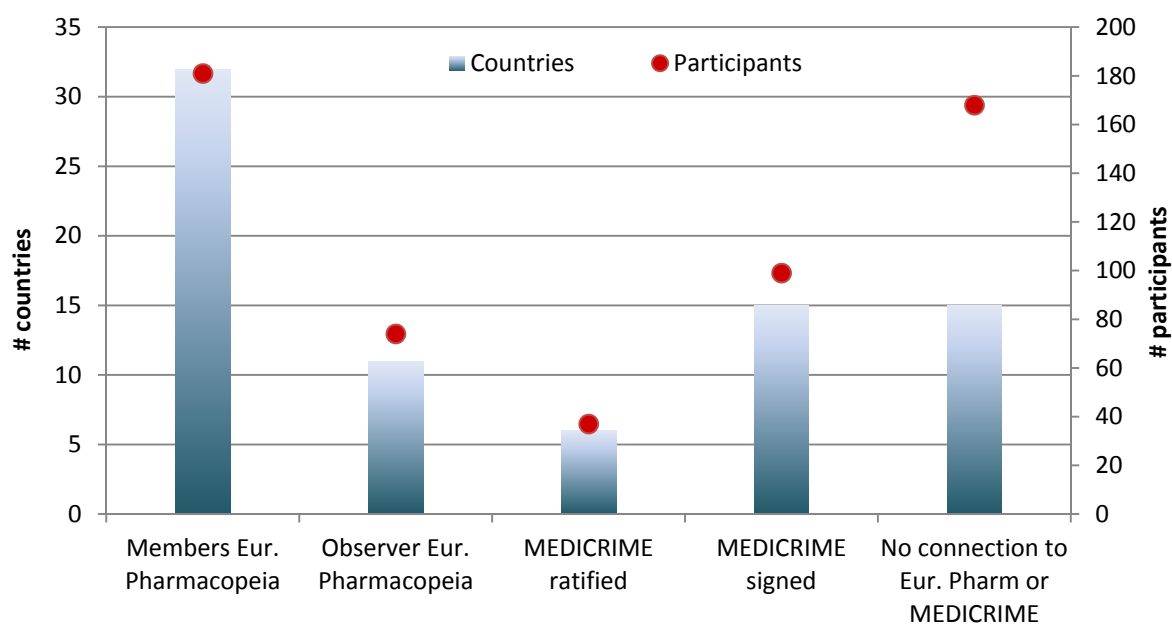
**Information about Participants**

A total of 423 participants from 58 countries have participated in training sessions related to counterfeit / falsified medical products. The graphs below show from which region they come, the status of their countries with regard to the Pharmacopeia and the MEDICRIME convention, as well as their professional background.



For ease the participants have been grouped according to the United Nations regional groups

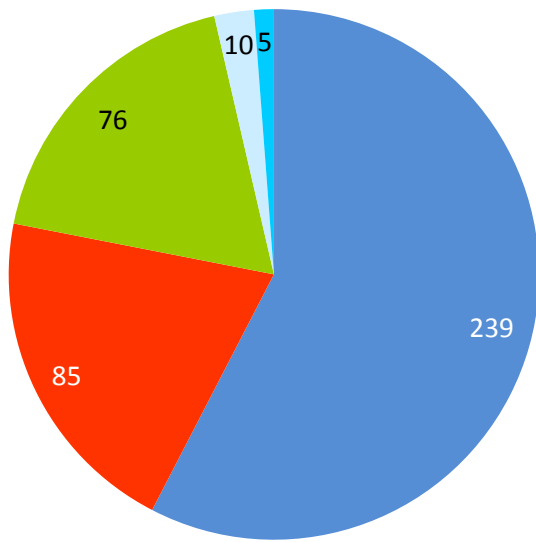
Number of countries and respective participants represented according to their status with regard to the European Pharmacopeia and the MEDICRIME convention.
